**Part 1: A General Commitment**

The Board of Directors is the governing body for Check for a Lump and is responsible for providing guidance to our organization to accomplish and our mission. In addition, board members oversee all governance duties, assist in creating strategic goals, ensure financial responsibility, approve the annual budget, evaluate the performance of the CEO, advance our image in the community, and provides expertise and knowledge.

As part of your commitment to supporting Check for a Lump and serving on the Board of Directors, we ask that you enhance our non-profit by committing to the following:

- Familiarize yourself with our mission statement, vision statement and core corporate values, and share these when appropriate opportunities arise
- Learn the details and the impact of all of our programs to effectively share them with our community (We will provide a workshop for you to attend to learn the details of our programs)
- Attend at least 4 of our 6 bi-monthly board meetings, at 5:30 - 7:00 pm in January, March, May, July, September, and November - day to be determined by board.
- Sign up to serve on an event committee and give approximately 15 hours of your time serving the committee
- Publicly share and attend our 2 signature Check for a Lump fundraising events per year--
  - Wig Out Gala (Weekend 1 week before Easter)
  - Pink Out 5K (1st Saturday of October.)
- Stay connected to our mission by attending at least one Survivor Survivors Unite event, 3rd Thursday of every month 5:30-7:00.
- Attend Board Retreat – January each year
- Commit to perform monthly breast self-exams and recommended routine mammograms (as applicable)

## **Part 2: Financial Commitment – Give, Get or In-Kind**

Check for a Lump board members are expected to be a philanthropic example to our community. We ask that you commit to give, get and gather in-kind donations for Check for a Lump to the best of your ability. We will assist you with coaching techniques.

**Give:** Giving is an expectation of board service and we ask each board member give the minimum of one wig or a higher amount that is meaningful to you at our yearly gala. We also ask that each board member fill at least one table for the annual gala.

- Wig Donation = \$300
- 1 table at the annual Gala = 8 tickets = \$2,000

**Get:** The Check for a Lump fundraising program is a collaborative effort between the staff, the board and our supporters. Our donors give because they support our mission. Maintaining an excellent relationship with our donors and introducing new people to our mission and programs is essential to sustaining our programs. We have several options for Board members to participate in fundraising at their personal comfort levels. We will provide you with coaching and support for any of the options below. Our expectation is that each board member will help raise an additional \$1,000 throughout the year. Examples of fundraising:

- Registrations/ticket sales for Check for a Lump events
- Host your own fundraiser
- Procure silent auction/raffle items
- Pro bono professional services
- Personal donation
- Secure donations from personal/professional contacts
- Employee matching programs or related donation programs
- Solicit and secure sponsorships
- Solicit and secure advertisement in our magazine

The Check for a Lump CEO will meet regularly with each member for feedback on commitments and to provide coaching and assistance to ensure each member's success.
